## Holiday to Remember Raffle - Rules of Play

1. In order to qualify for the prize, the ticket must be paid in full at the time of the draw. Payment can be made by either cash, check or credit card.
2. The draw will be made at 320 Maple Street, Fredericton, NB on December 11th, 2020 at 12:00 noon AST. All ticket sales and entries must be received by 11:45 am AST, December 11<sup>th</sup>, 2020 in order to qualify for the draw.
3. The winning ticket number will be randomly drawn, and then be matched with the registered ticket holder.
4. Winners consent to the release of their names by the Alzheimer Society. The winner will be declared on our website and on our Facebook page, and will be contacted directly by telephone and / or email with clear instructions how to claim their prize.
5. The winner will have 48 hours to claim their prize by contacting the ASNB using the information provided. In the instance that the winner does not claim their prize within 48 hours, another winner will be selected and the same process outline in rule 3 will be followed. This process will be repeated until the prize is claimed.

7. Please note – there is no cash value for this prize.
8. There is no age requirement to enter this raffle.
9. The following people are not permitted to purchase tickets in this lottery: Board members or staff of the Alzheimer Society of New Brunswick, and their immediate family (spouses, siblings, parents, children, grandparents, and grandchildren).
10. A non-resident of New Brunswick (“Non-Resident”) may purchase a ticket only if the entire payment transaction takes place while the person is physically in New Brunswick and if the ticket is issued at that time. Tickets will not be distributed to, emailed, mailed or otherwise sent to a Non-Resident’s third-party address in New Brunswick. A non-resident winner of a prize is responsible for all costs associated with delivery of prize to the location the winner specifies, that is outside the province of New Brunswick.
11. The odds of winning the prize is 1 in 2500.
12. The records of Alzheimer Society of New Brunswick shall be deemed correct if there is a discrepancy in numbers.
