- Mind in Motion and Personalized Musical I-pods




## **2019-2020 Services Delivered**

- 7863 visits of support to 750 families in caregiver support
- 235 group sessions to 2506 public participants & 1492 attendances from 275 family and PLWD.
- E-newsletters developed and circulated monthly
- 3605 attendance days at day program for 114 individuals
- Services offered in both official languages
- Dementia Friendly Community Memory Activity Kits with our libraries
- 22 Memory Clinics staffed and 187 people seen
- 3 6-week consolidated day program and caregiver respite programs (Finch, Maxville, Embrun)
- 4 8-week Mind in Motion programs (Williamstown, Cornwall, Embrun)
- 70 IPod Music program provided



# **Preferred Language**




Anglophone 55%

### Relation to the Person with Dementia




- Child 35%

- Person with Dementia 5%






### Living Arrangements
