We appreciate your support and continue to look forward to working with you in the future and to provide the much needed support those in our community require.



Program Highlights

Services and programs saw large scale delivery disruptions, with all service and support programs shifting to some form of virtual delivery. Referrals and Intake saw contraction from March through the entire first quarter, recovering slightly in Q2. Q3 and Q4 continued to trend back up towards normal baseline volumes in some services, however all Adult Day Services and Respite care options remained closed to in person delivery for the entire fiscal year, accounting for the 5% decrease in the units of service. Number of individuals served was maintained via virtual delivery, but reported negligible growth again as a result of limited services due to the pandemic.


