# Rules of Play Alzheimer Society of Sarnia-Lambton Worn and Buff It Custom Kitchen Renovation Lottery Draw January 5, 2022 @5PM

The Worn and Buff It Custom Kitchen Renovation Lottery is being conducted by the Alzheimer Society of Sarnia-Lambton.

\*This is a prize lottery.

### 1.0 Grand Prize:

- 1.1 One prize will be awarded valued at \$50,000.00, which includes the following:
  - Kitchen design, cabinets, islands, countertops and installation from Sarnia Cabinets value of \$30,000
  - Electrical and Lighting from Burdett Electric Ltd. and Twin Bridge Lighting value of \$2,500.00
  - Kitchen sink, faucets and plumbing services from Pete's Plumbing value of \$4,000.00
  - Kitchen Flooring/ backsplash tiles from Hucker Floor Coverings value of \$6,500.00
  - Painter & paint supplied by Bigras Painting value of 1,500.00
  - Kitchen appliances (ie. fridge/stove/dishwasher) from North End Appliance value of \$5,500.00
- 1.2 \*All values stated are in Canadian \$.
- 1.3 \*Any additional costs/ fees above and beyond the stated maximum prize value outlined above, will be the prize winner's responsibility.
- 1.4 \* Lottery means the drawing of a ticket from among the tickets sold for the specific raffle causing the holder of the ticket drawn to: (a) win a prize equal to the Grand Prize defined in 1.1 above.
- 1.5 \*Any costs incurred as a result of structural changes to the existing layout/design of the kitchen, (ie. removing walls) will be the responsibility of the winner.
- 1.6 \* Grand Prize is as described above and cannot be redeemed for cash.
- 1.7 \*Winner must redeem prize package by January 5, 2023. In the event that the prize package cannot be redeemed by January 5, 2023 due to an event which prohibits vendors from starting or completing work in the home, the vendors will extend the deadline and commence work as soon as possible.

# 2.0 Eligibility:

- 2.1 The following individuals, all of their immediate family members and anyone residing in the same household is prohibited from purchasing a ticket:
- (i) Board members and employees of Alzheimer Society of Sarnia-Lambton;
- (ii) Lottery Committee Members and partners;
- (iii) Partners, employees and immediate family members of the following suppliers: Sarnia Cabinets, Burdett Electric Ltd., Twin Bridge Lighting, Pete's Plumbing, Hucker Floor Coverings, Bigras Painting, North End Appliance Centre, 2727090 Ontario Limited.
- 2.2 Lottery ticket purchaser must be at least 18 years of age. Tickets cannot be ordered in the name of a minor. Only tickets that have been paid for and/or have been verified as paid for are eligible to be entered for the draw. Tickets must be purchased and mailed in the province of Ontario. In the event of an invalid credit card, tickets issued will be considered invalid. The name on the ticket must be an individual over the age of 18 who resides within Lambton, Kent, Huron, Middlesex or Elgin Counties. If not, the ticket will be considered invalid and the purchase price will be credited to the purchaser. Official tickets ordered on-line, or by phone will be delivered to the purchaser via mail within 2-3 weeks after credit card has been charged or e-transfer has been received.
- 2.3 Grand Prize must be used within **one household** within Lambton, Kent, Huron, Middlesex or Elgin Counties. **Note:** the prize is limited to households within these counties due to the additional cost to vendors for travel, lodging, transportation, shipping etc to locations outside these areas.
- 2.4 By purchasing a ticket, you agree to allow the Alzheimer Society of Sarnia-Lambton the right, if you are a prize winner, to use and publicly disclose your first and last name, municipality of residence, image, photograph and likeness as a prize winner in any means required by the terms of our lottery license and/or that we consider appropriate for purposes of administering and promoting the lottery, without notice, review or approval or additional compensation to you.

- 3.0 Ticket Details and Handling:
- 3.1 Tickets may be purchased on-line by visiting <a href="https://alzheimer.ca/sarnialambton/en/home">https://alzheimer.ca/sarnialambton/en/home</a> and clicking the link, which will redirect you to an EventBrite page, in-person by calling 519 332 4444 or through an employee or approved sales agent of the Alzheimer Society of Sarnia-Lambton. **Note:** The name on the ticket must be an individual over the age of 18 who resides within Lambton, Kent, Huron, Middlesex or Elgin Counties.
- 3.2 Tickets are **\$50.00 each.**
- 3.3 Method of payments:
  - (i) Cash
  - (ii) Credit Card
  - (iii) E-Transfer
- 3.4 Tickets will be issued in sequential order and will begin with 0001 license #.
- 3.5 \*Only one name may be recorded on a ticket.
- 3.6 The official ticket is a receipt of purchase. Purchaser's name and contact information must be legibly written on the ticket stub. It is the responsibility of the ticket purchaser to ensure that they receive their ticket(s) in advance of the draw. Ticket purchases are not tax-deductible. The liability of the licensee of this lottery shall be limited to the purchase price of the ticket.
- 3.7 Tickets that are sold will be secured in a locked safe at the Alzheimer Society of Sarnia-Lambton prior to the raffle and in a raffle drum during the raffle.

## 4.0 Chances of Winning:

- 4.1 The maximum number of tickets available for sale is 5,000. The chances of winning are dependent on the number of tickets sold.
- 5.0 Ticket Deadlines and Draw Dates:
- **5.1 Final Ticket Sales Deadline:** Eligible tickets must be purchase by 12 pm (noon) on December 28, 2021.
- **5.2 Draw Date:** Winning ticket will be drawn on January 5, 2022 at 5PM. A Backup winning ticket will be drawn at the same time.
- **5.3 Draw Location:** Sarnia Cabinets, 1321 Plank Road, Sarnia, ON. Draw will be livestreamed and posted to the Alzheimer Society of Sarnia-Lambton's Facebook page.
- **5.4 Announcement:** January 5, 2022 at 6PM

- 5.5 Winning ticket will be drawn from a raffle drum by a designated representative from Sarnia Cabinets. The draw will be made using the stub ticket method –the numbered ticket is provided to the buyer of the ticket and the corresponding numbered stub is placed in a draw drum the numbered stubs correspond to each numbered ticket.
- 5.6 Winner **DOES NOT** need to be present to win.
- 5.7 Ticket forms and all financial documents will be preserved after the final draw in accordance with regulations.
- 5.8 In the case the draw for this raffle cannot be held on the date and times hereinbefore fixed, such draw shall be held when practicable. ### 6.0 Prize Claim

- 6.1 Grand Prize will be awarded to the primary ticket holder (name that appears on the ticket). Winning ticket, (winning ticket means a ticket bearing a number or numbers, corresponding in such manner as the Alzheimer Society of Sarnia-Lambton shall determine to a winning number or numbers drawn as provided herein or otherwise determined on the outcome of the raffle) must be presented to claim the prize. In the event the winning ticket stub is lost, the winner would be required to provide Government issued ID. Winner must initially claim the prize. Any transfer of prize from the winner to a third party must be arranged independently of the Worn and Buff It Custom Kitchen Renovation Lottery.
- 6.2 Grand Prize is as described above in 1.1 and cannot be redeemed for cash.
- 6.3 The Alzheimer Society of Sarnia-Lambton will notify the primary ticket winner by phone, electronically via email, or by mail. Every reasonable effort will be made to contact the winner.

- 6.5 Contact information for the winner will be shared with the Licencing Authority.
- 6.6 Prize winner is asked to claim the prize within one week from the date of the draw following notification. Any prize not claimed within one week from the date of the draw, will be awarded to the backup winning ticket holder. Any prize which is not claimed shall be secured for a period of six months from the date of the draw. Unclaimed prizes will be reported and a charitable allocation will be approved by the licensing body. Licensees must keep records of the attempts made to

contact the winner as part of the documentation retained under the terms and conditions of the licence.

# 7.0 Privacy

7.1 This event is administered by the Alzheimer Society of Sarnia-Lambton in co-operation with the preferred suppliers highlighted under the Grand Prize details. This information is protected and governed by the privacy policies of the Alzheimer Society of Sarnia-Lambton. Any personal information that you provide is collected for the purpose of fulfilling this Lottery, promoting future such lotteries and other fundraising activities. The Society does not rent, sell or trade our mailing lists.

### 8.0 General

- 8.1 The heading in these rules are for convenience of reference only and do not affect the interpretation of these Rules.
- 8.2 The licensee may amend these Rules at any time and in any manner with approval from the City of Sarnia.
- 8.3 The governing law shall be the laws and regulations in the Province of Ontario.
- 8.4 The licensee reserves the right to intercept, in whole or in part, one or more prizes in accordance with applicable family legislation, as amended from time to time, and will be held harmless from any claims in respect of this action.
- 8.5 There shall be no refunds.
- 8.6 Raffle lottery tickets sold under a license issued in Ontario must not be advertised, offered for sale, sold or ordered from outside of Ontario. While they are in Ontario, residents of other countries or provinces may purchase raffle tickets sold under a license issued in Ontario.
